**Deadline:** Registration materials must be sent back postmarked no later than **APRIL 1, 2019**. We may, at our discretion, accept late registrations on line for an additional fee of \$50 per child.

**Costs:** Camp fees will be **\$120** per student in most camps and **\$170** per student for Teen Camp. All registrations must include full payment of camp fees. FFIC is no longer charging membership dues. Fees increased this year due to rising facility and activity costs.

## What is Heritage Camp?

Heritage Camp is celebrating its 32<sup>nd</sup> anniversary in 2019. Heritage Camp is a day camp that provides an opportunity to learn about various ethnic heritages. FFIC is an adoptive family support group and the camp lets many children experience their birth cultures. We also welcome siblings, friends, and any other children who wish to participate. In general, campers are grouped by the grade they will be entering in Fall 2019. Smaller sessions are grouped into multi-age classes as appropriate. Heritage Camp includes the following Sessions:

**PRESCHOOL:** This multi-heritage camp is open to children of all ethnic groups. Children must be 4 years old by December 1, 2019 and be toilet-trained. Registration for Preschool is limited to 24 campers. Don't forget to include your child's birth country on the CAMP REGISTRATION form. If enrollment is low, children may be placed in the camp of their birth culture.

**CHINA:** This camp is for children in K-6 who are interested in Chinese culture.

**EURASIAN:** This camp is for children in K-6 who are interested in Eurasian and former Soviet culture. Please indicate your child's birth country (e.g. Russia, Ukraine, Romania, Kazakhstan, etc) on the registration form.

**Ethiopian:** This camp is for children in K-6 who are interested in Ethiopian culture.

**KOREAN:** This camp is for children in K-6 who are interested in Korean culture.

**LATIN AMERICAN:** This camp is for children in K-6 who are interested in Latin-American culture. Please indicate your child's birth country (e.g. Guatemala, Colombia, etc) on the registration form.

**GLOBAL CAMP:** Global Camp is a multi-cultural group in the spirit of our Preschool and Teen Camps. Global Camp will initially begin with two classes, grades K-3 and 4-6. We are encouraging (but not limiting) registration to children adopted from countries such as Haiti, Vietnam, Thailand and India. Global camp is also available to any child or sibling open to learning about another culture outside our current China, Korea, Latin American, Eastern European, and Ethiopian camps.

**TEEN CAMP:** This camp is open to children of all ethnic groups entering 7<sup>th</sup>, 8<sup>th</sup>, or 9<sup>th</sup> Grade in the fall of 2019. Teen Campers participate in a variety of activities, many off-campus. Please note that the cost is \$170 and there may be additional fees to cover special activities.
